Government Reveals Cover Up: Members of STM '61 Likely Beneficiaries of Vast **Financial Interests**

While doing research for this issue of the STM '61 *Newsletter* members of the writing staff uncovered questionable circumstances surrounding the late '40's and early '50's sale of Farmer Duff's vast property holdings located on the south end of St. Thomas More Parish Some "Pioneer" members of the parish who were interviewed for this article (most in their 80's and 90's) recalled that Duff's original property was bounded by 83rd and 87th

Streets on the north and south, respectively, and California Avenue on the west and the B & O railroad tracks on the east. "In the late 1940's and early 1950's the Duff Farm had a thriving



produce stand during the summer and early fall," one STM octogenarian stated, "and evervone shopped

Philander Duff there. Then it seemed

that overnight it was gone and houses were being built there." Some members of

STM '61 also remember Farmer Duff's property well. "Until about the third grade we used to go there all the time because it had a pond called the B.A.B. ("bare ass beach") and we'd pick and dry the cattails and then smoke 'em." Another recalled, "In the hot summer months we'd go there to swim. We'd catch the cravfish and frogs. Sometimes we'd put a lady finger firecracker in a frog's mouth, light the fuse and then watch as it hopped away. It was something when it exploded – sending body parts in all directions.

I think that's how I acquired my taste for lightly sautéed frog legs." None of the boys of STM '61 could be reached for comment about what they remember.

Irregularities in the real estate transaction documents of the Duff property prompted the Newsletter investigative team to file a Freedom of Information Act (FOIA) request with the federal

government. Its recent reply to this request, given exclusively to this publication, contains stunning information that will require more detailed analysis and will, in all probability, lead to protracted litigation. Commenting on the basis of strict confidentiality, a panel of leading trial to maintain ownership of his property. For reasons only lawyers assembled at the request of this publication predicted, "If successful, this litigation will favorably affect the redoubled its effort to acquire his land due largely to the financial well-being of every member of STM '61."

At this time, it can be reported that some of the highlights in the government's reply (supported by thousands of documents kept secret by it for the past 60 plus years) include the following:

•During WWII the Department of Defense (DOD) implemented a wartime plan that required its acquisition of large tracts of land near strategic resources (such as steel plants and airports) in major U.S. cities;

•Farmer Duff's property was chosen because of its proximity to both the South Chicago steel works and Midway Airport (then the world's busiest). Since aircraft landing radar beacons for Midway were already located and in use on his property, Duff's land became all the more valuable. Duff, acting on his own and without the aid of legal counsel, vehemently resisted the DOD's effort to acquire his property (which, contrary to popular belief, extended beyond California on the west all the way to Kedzie). He


questioned not only the need of the taking but the price per acre he was to receive. In early 1945, the government established its need to acquire all of Duff's property leaving only the matters of the date of acquisition and remuneration to be determined. Documents show that this was to have been done in December of that year and that Duff would be allowed to continue to farm the land until remu-

neration was made. Victories in Europe and over Japan, however, caused some members of the DOD to rethink the wartime plan and, consequently, the need to acquire the Duff property;

•With the end of the war Farmer Duff renewed his efforts now made clear from the government documents, the DOD efforts of one man - Joseph McCarthy. This is the same McCarthy who would later gain infamy for his, "I'll find and fry every 'pinko commie' in our country" campaign;

•In 1946, McCarthy was running for a Senate seat from his home state of Wisconsin. According to a report dated September, 1946, he and an unidentified member of his campaign staff made an unannounced on-site visit to the recalcitrant Farmer Duff's property a month earlier. At the time of the visit, Duff was harvesting tomatoes in an area west of California Avenue (later to become Charles Carroll Park). As McCarthy approached the working farmer he made overtures about the importance of the site becoming a part of the "U.S. Government neighborhood" and Duff's need to show his true allegiance to his country.

In their review of public documents (recorded in the Cook County Recorder of Deeds Office) transferring Duff's property to the U.S. government they noted gross variations in the signature of Farmer Duff. Comparison of Duff's signature on court documents filed with the Circuit Court of Cook County in 1945 to the recorded deeds and other documents of conveyance after 1947 simply do not match.

Faced with this overwhelming evidence which was McCarthy vowed loudly, "I'll get you, and your land, you substantiated in the many documents produced via its reply to the FOIA request, the government has now admitted that •Thereafter, Duff fought valiantly to retain ownership in 1947, at the direct order of Senator McCarthy, members of a highly secret military team covertly descended on favor of the government and the Cold War beginning to Duff's property with orders to hold him both under house arrest and in communicato "for as long as it took" for him to transfer ownership of all his property to the government. Further, they were to work the farm and tend the seasonal farm stand until the mission was complete to allay any suspicion of the government's activities. Totally isolated from the outside world (Duff, like both his parents, was an only child and a life-long bachelor who lived alone but was known to hire farm hands to help with his planting and harvesting) and subject to constant physical and mental abuse, he eventually capitulated to the demands of his "captors".

By late August, 1953, the now broken Duff signed his name to the last of the deeds and was released. The total acreage of his farm that he conveyed under duress to the government was more than 240 acres.

> roaming STM Parish. Significantly, a number of reports indicate he would stand across from STM School and watch the children coming and going in the morning and afternoon. A report dated late September, 1953, indicates:

"...Duff entered the St. Thomas More School building and remained therein for several hours. Upon leaving the school Duff proceeded to the

'beanery', a public restaurant located in the gray clapboard hotel in the railroad yard used by railroad men located on the north side of 79^{th} Street at California. This field agent kept the premises under surveillance from across 79th street. After waiting an hour for the subject to reappear I entered the restaurant to confirm his presence therein. A thorough search failed to reveal the presence of Duff. After calling for and receiving assistance from other agents a thorough search of the entire building and the complete rail yard facility failed to disclose the whereabouts of the sub*ject. It is assumed Duff hopped one* of the passing freight trains." Sadly, that was the last recorded contact anyone has had with Framer Duff.

In their effort to account for all of Duff's actions in the final hours of their surveillance of him. about a week after his disappearance federal agents questioned the principal of STM School, Sr. Anisasia, who

confirmed her first and only meeting with Duff had occurred approximately one week earlier. As shown in an official report produced under the FOIA request, an agent wrote, "She stated, 'Mr. Duff appeared calm and thoughtful throughout our entire meeting which lasted several hours. He explained that he had no formal education as he had always worked his farm with his father and mother. Both his parents were dead and, he said, like both his parents he had no siblings, and he had never married. He said he wanted to make a donation to some of the children in the school but he knew no individuals by name. He asked me

who the youngest pupils were in the school. I replied, 'the first graders'. He asked me if they would still be in school 7 years hence. I advised that at that time they would be the 8th grade class – the graduating Class of 1961. At that point he asked if I would help him draft a will. I was hesitant at first but he seemed so earnest and intent that I couldn't help but agree. It took only about 30 minutes and it was done. In essence, it stated that he had no family and that whatever property, real or personal, he owned he was leaving to any person who graduated from STM in June, 1961. At that point, I had three of the other sisters come into my office and witness him as he signed his "Last Will and Testament". It so happened _

Here, then, is the U.S. Government's unbelievable initial settlement offer:

(A) An outright, tax-free cash payment to each member of the Class, or his heirs, in the amount of \$500,000,

-OR-

(B) If a simple majority of the members of STM '61 do not want to accept an outright cash settlement then the U.S. Government will take, via eminent domain proceedings, all of the original property included in the Duff Farm. Every building on the property will be razed and every other above-ground improvement will be removed. Each member of STM '61 will be granted an interest in the property. The Class will be allowed, as a single unit, to present a unified plan for the redevelopment of the Duff Property to the Federal Government. All reasonable elements of the plan accepted by the government will be paid for by the government.

As a result of this initial meeting, those gathered were able to fashion a reply to the government's settlement offer in the form of a list of demands. These demands were forwarded to the DOJ and within a period of only 10 days this publication received the government's reply. It can be reported at this time that the following initial demands of STM '61 have been **agreed** to <u>in principle</u> by the government:

Extent of the Duff Property (240 acres) as seen in satellite photo provided by the U.S. Government



(1) All of Duff's real estate holdings are to be held in trust by the U.S. Government for the beneficial use of the members of the Class of STM '61 for life. In other words, a life estate interest (LEI) in each member of the Class will be established in the whole of the property and upon the death of the last member of the Class all interest in the property will revert to the government;

(2) The property is to be developed by the government to meet the reasonable specifications of STM '61. Further, all costs for maintaining the property and all improvements thereto or thereon will be paid by the government until the last LEI ends;

(3) During the time of any LEI, the government will be responsible for all security, upkeep and maintenance of all the property including improvements thereto at no expense to any LEI. No LEI will pay any cost associated with the property including real estate taxes (the *Newsletter* is informed this is somewhat similar to the American Indian Reservation model);

(4) To insure the privacy of this land, the entire property will be enclosed with eight foot wrought iron fence. Access to the property will be via several strategically placed entry points guarded by members of the U.S. Marshall's Service;

(5) Initial improvements are to include the following:

(A) New single family homes, townhouses and condominiums will be constructed according to a plan now being designed by architects of the Class in conjunction with input from those in the building trades. Each Class member will choose what type of residence they prefer to live in;

(B) An 18 hole championship golf course to be designed by Tiger Woods will be constructed and run throughout the property. A club house with state of the art outdoor recreational facilities is to be constructed;

(C) A wildlife preserve (only pheasant hunting will be allowed in season) will be established on the southern border of the property along 87th street from the B&O Railroad tracks on the east to the current easterly property line of Luther High School on the west;

(D) The current Luther South High School building will be gutted and remade into assisted living residences with a 24-hour health care clinic and an acute emergency care facility. Ambulance service for transport to local hospitals will be available when necessary. A helipad will be constructed to accommodate helicopter service for transport to other hospitals (and for transport to and from both Midway and O'Hare Airports for the non-medical convenience of Class members). All of the healthcare professionals, including helicopter pilots, will be members of the U.S. Armed Forces. All of their services will be provided at no cost to resident Class members, their spouse or significant other, and any dependent adult child who qualifies.
